1. I have to submit the Annual Report in accordance with the provisions of Section 60(1) of the Employment and Industrial Relations Act (Cap. 452) for the period 1st. July, 2008 to 30th June, 2009.

2. At the beginning of the period under review there were 49 organisations on the register, made up of 31 Trade Unions and 18 Employers' Associations.

3. During the period under review:

- a. No Trade Union or Employers' Association was registered.
- b. The following Trade Union was cancelled: The Middle Sea Insurance Staff Union.

Thus at the end of the said period there were a total of 48 organisations, comprising of 30 Trade Unions and 18 Employers' Associations on the register.
