

EMPLOYMENT AND INDUSTRIAL RELATIONS ACT (CAP. 452)

**Report by the Registrar of Trade Unions
2023-2024**

1. In accordance with the provisions of Section 60(1) of the Employment and Industrial Relations Act (Cap. 452), I am hereby submitting the Annual Report for the period 1st July, 2023 to 30th June, 2024.

2. At the beginning of the period under review, there were 54 organisations on the Register, made up of 42 trade unions and 12 employers' associations.

3. During the period under review:

a) Two trade unions were registered, being: St. John's Co-Cathedral Employees Union and Solidarjetà.

b) No employers' association was registered.

c) No trade unions nor employers' associations were cancelled. However, steps are being taken to cancel 5 trade unions and 2 employers' associations who are either being dissolved or have not submitted their annual returns.

Thus, at the end of the said period, there were a total of 56 organisations, comprising of 44 trade unions and 12 employers' associations on the Register.

4. The membership strength of trade unions and employers' associations as reported to the Registrar of Trade Unions when compared with those of the previous report are as follows:

5. During the period under review, 18 verification exercises were concluded by the Department for Industrial and Employment Relations in accordance with the Recognition of Trade Unions Regulations, 2016.

The organisations which failed to render any returns by law, including the audited accounts for 2023, are: - Assoċjazzjoni Bejjiegħa tal-Laham/Meat Sellers Association, The Lotto Receivers Union; Energy Senior Staff Union, Haddiema Università ta' Malta, Midwives of Malta, Association of Airline Operations Controllers (Malta); Independent Bankers Union, Union Law Court Employees, Association of Catering Establishments, Union Professjonisti tal-Wasteserv and Union of AGV Malta Employees.

7. The organisations which submitted partial returns but failed to render the audited accounts for 2023 are:
