1. INTRODUZZJONI

(1) Dan il-kaz gie mibghut quddiem it-Tribunal Industrijali mill-Onorevoli Ministru tax-Xoghol u Servizzi Socjali nhar l-14 ta' Frar, 1985 skond il-provvedimenti tal-artikolu 26(2) ta' l-Att XXX ta' 1976 dwar ir-Relazzjonijiet Industrijali u skond il-provvedimenti ohrajn tat-Taqsima III ta' l-istess Att li ghandhom x'jaqsmu mat-temm obligatorju ta' tilwim ta' xoghol.

(2) It-Tribunal Industrijali zamm erba seduti qabel ma wasal ghal din id-decizjoni preliminari.

(3) It-Taqsima Tessuti, Hwejjeg u Gild tal-General Workers' Union hija rapprezentata mis-Sur Edmond Mallia, President tat-Taqsima u mis-Sur Anthony Zarb, Agent Segretarju tat-Taqsima fl-assenza tas-Segretarju tat-Taqsima, is-Sur Arthur Micallef.

Il-Kumpanija, Model Knitwear Industries Limited, hija rraprezentata mis-Sur Silvio Zammit, Direttur u General Manager tal-Kumpanija li hu assistit mis-Sur Alfred Mallia Milanes għan-nom ta' l-Employers' Association.

2. 'TERMS OF REMIT'

(1) It-'Terms of Remit' tat-Tagħsim Tessuti, Hwejjeg u Gild tal-General Workers' Union huma dawn li jidhru hawn taht:

'That the Company, Model Knitwear Industries Limited (Gozo), shall honour the Agreement reached by the Company with the Textile, Garment and Leather Workers Section of the General Workers' Union on the 10th September, 1984, copied herewith. If necessary, the Industrial Tribunal is being requested to order the Company to start the negotiations as undertaken in terms of the Agreement'.

(2) It-'Terms of Remit' tal-Kumpanija, Model Knitwear Industries Limited, huma dawn li jidhru hawn taht:

'(A) That the Company, Model Knitwear Industries Ltd (Gozo) has honoured the Agreement reached with the General Workers' Union on the 10th September, 1984, in that it started negotiations and exchanged proposals with a view to contracting an Industrial Agreement.

(B) In order to conform with the requisites of Maltese Industrial Law and practice, the Company had in its counter proposals asked the General Workers' Union to substantiate its claim to having the required majority in membership of the Company's wholetime work force. This substantiation was not forthcoming from the General Workers' Union; so the Company could not continue with its negotiations, as this would have led to a situation which does not conform with local law and practice and

would have, therefore, been illegal, unethical and not in the interest of the majority of the wholetime employees of the Company. Rather than settling an already disturbed, situation, this would have involved the Company in more industrial strife.

(C) It is, therefore, being submitted with respect that the Tribunal will:

- (i) confirm that the Company is not in a position under current Law and practice to negotiate an Industrial Agreement; and
- (ii) order the General Workers' Union to desist from taking any further action in this respect.

Wara x-xhieda tas-Sur L. Cilia Debono, Direttur tax-Xoghol u Emigrazzjoni, it-Tribunal Industrijali ordna li jitelghu jixhdu x-xhieda kollha fuq punt wiehed biss li kien:-

'Jekk il-kwistjoni tal-maggornaza ta' membri fil-General Workers' Union u r-rikonoxximent tal-General Workers' Union mill-Kumpanija gewx diskussi fil-laqgħa tal-Hadd, 9 ta' Settembru, 1984 li wasslet għal firmar tal-ftehim ta' l-10 ta' Settembru, 1984 bejn iz-zewg partijiet'.

4. DECIZJONI PRELIMINARI

Wara li studja l-kontenut tat-Terms of Remit' taz-zewg partijiet li jirreferu għal-ftehim li ntlahaq bejn l-istess zewg partijiet fl-10 ta' Settembru, 1984; il-kontenut tal-ftehim innifsu u x'intqal mix-xhieda, it-Tribunal Industrijali nnota li:


(1) Il-ftehim ta' l-10 ta' Settembru, 1984 ma għandu l-ebda provvedimenti rigward il-maggornaza jew le ta' membri tal-General Workers' Union u l-għarfien tal-General Workers' Union mill-kumpanija. Dan il-ftehim gie ffirmat mis-zewg partijiet - jigifieri, mis-Sur Salvino Cutajar għall-General Workers' Union u mill-Avukat Victor Bajada LL.D. għall-Model Knitwear Industries Limited, fil-prezenza tas-Sur Anton Hili bhala rapprezentant tad-Direttur tax-Xoqhol u Emigrazzjoni, li fferma l-istess ftehim ukoll.

(2) Il-parti l-kbira tax-xhieda qalu li l-punt dwar il-maggornaza tal-membri fil-General Workers' Union u l-għarfien tal-General Workers Union mill-kumpanija ma gewx imqajma waqt il-laqgħa tad-9 ta' Settembru, 1984.


(3) Il-punt li jirrigwardja l-maggornaza tal-membri tal-General Workers' Union imqajjem f'din it-tilwima tax-xoqhol johloq kaz preliminari fuq konfront mal-ftehim ta' l-10 ta' Settembru, 1984. Decizjoni fuq dan il-kaz preliminari mhiex fil-kompetenza tat-Tribunal Industrijali u għaldaqstant it-Tribunal ma jistghax ikompli jisma din it-tilwima tax-xoqhol qabel jigi riz lut il-kaz preliminari minn Qorti kompetenti.

F'dan l-isfond, it-Tribunal Industrijali jaggorna 'sine die' u jordna li z-zewg partijiet jiehdu l-kaz preliminari guddiem Qorti Ohra, sabiex tkun tista tinghata sentenza jekk il-ftehim ta' l-10 ta' Settembru, 1984 ghandux validita' bhala kuntratt indipendentament mill-meriti l-ohra li qeghdin guddiem dan it-Tribunal Industrijali.

It-Tribunal Industrijali, waqt li jaggorna l-kaz Nru 363 'sine die' sakemm jigi razzolut il-kaz preliminari kif imsemmi hawn fuq, jirrakomanda li ma jkun hemm l-ebda azzjoni li taqgha taht ir-relazzjonijiet industrijali minn xi wahda mis-zewg partijiet, jigifieri li jibqa li 'status quo' sakemm jerga jibda jinstema l-kaz guddiem it-Tribunal Industrijali, kif kostitwit, u jinghata l-Award.
