Sir,

1. I have to submit the Annual Report in accordance with the provision of Section 14(1) of the Industrial Relations Act, 1976, for the period 1st July, 1987 to 30th June, 1988.

2. At the beginning of the period under review there were 42 organisations on the register, made up of 21 Trade Unions and 21 Employers' Associations ~~were registered during this period.~~

3. The Casino Employees Union; Gozo Bus Owners Association; Association of Artists for Radio, Television, Stage and Screen; Association of Certified First Class Marine Engineers and Yacht Traders Association were registered during this period.

4. The membership strength of Trade Unions and Employers' Associations as compared with those of my previous report are as follows:—

5. No routine inspections were carried out during the period under review.

6. The Association of Self-Catering Accommodation (No. 218) and the Macaroni-Manufacturers Association (No. 100) were dissolved and subsequently cancelled. The Coaches Transport Service Association (No. 213) failed to submit the required returns as required by law and was therefore cancelled.

7. The returns show an overall increase of 151 in membership from last year.

8. The organisations which failed to render complete returns as required by law are The Lotto Receivers Union, The Association of Self-Employed and Employees, The Ghaqda tad-Dulciera, The Ghaqda Bdiwa Progressivi, The Middle Sea Insurance Staff Union, The Association of Tractor and Trailer Operators/Owners, The Union Haddiema Coca-Cola, The Medelec Switchgear Union, The Ghaqda Haddiema Tessuti Ghawdxin, and The House Union Maldiam.
