

INDUSTRIAL RELATIONS ACT, 1976

Report by the Registrar of Trade Unions
1989 - 1990

The Minister for Social Policy

Sir,

1. I have to submit the Annual Report in accordance with the provision of Section 14(1) of the Industrial Relations Act, 1976, for the period 1st July, 1989, to 30th June, 1990.

2. At the beginning of the period under review there were 43 organisations on the register, made up of 24 Trade Unions and 19 Employers' Associations.

3. The AirMalta Executives Union and the Għaqda (Union) Inġiniera Professjonali tal-Korporazzjoni Tele-malta were registered during this period.

4. The membership strength of Trade Unions and Employers' Associations as compared with those of my previous report are as follows:—

6. The Association of Certified First Class Marine Engineers was dissolved and therefore cancelled.
