

INDUSTRIAL RELATIONS ACT, 1976

Report by the Registrar of Trade Unions
1991 - 1992

The Minister for Education and Human Resources

Sir,

1. I have to submit the Annual Report in accordance with the provision of Section 14(1) of the Industrial Relations Act, 1976, for the period 1st July, 1991, to 30th June, 1992.

2. At the beginning of the period under review there were 50 organisations on the register, made up of 30 Trade Unions and 20 Employers' Associations.

3. The Għaqda (Union) Professjonisti tal-Korporazzjoni għas-Servizzi ta' l-Ilma and the Għaqda tal-Furnara u Bejjiegħa tal-Hobz were registered during this period.

4. The membership strength of Trade Unions and Employers' Associations as compared with those of my previous report are as follows:—

5. No routine inspections were carried out during the period under review.

6. The General Importes Association and the "Union Haddiema tal-Hwienet" failed to submit the annual returns as required by law and were cancelled. The "Għaqda Pitkali tal-Hut" was dissolved and was therefore cancelled.

7. The returns show an overall decrease of 655 in membership from last year.

8. The organisations which failed to render complete returns as required by law are The Musicians and Entertainers Union, the Union of Government Medical Doctors, The Association of Artists for Radio, Television, Stage and Screen, The AirMalta Executives Union, Union Periti tal-Gvern u Parastatali, The Assocjazzjoni tal-Bdiewa, The Public Cleaners Association, The Association of Tractor and Trailer Operators/Owners, The Gozo Bus Owners Association and The Għaqda tal-Pitkala.
